The undersigned, of lawful age, being duly sworn, upon oath deposes and states as follows:

- 1. He is a City of Tuisa police officer assigned to Detective Division.
- 2. He has read certain official investigative reports and statements of witnesses regarding the above named Defendant(s) and from these reports it appears as follows:
- 3. On July 14, 2003 the father of the victim Mark Green contacted your affiant. Mr. Green stated that his son was kidnapped from the downtown Doubletree hotel assaulted and left for dead in Texas.

Your affiant contacted the Texas City Police Department Detective Joe Stanton, Who faxed his reports to me. The reports showed that the victim had numerous injures that were documented by the Texas City Police.

On July 31, 2003 at 1400 hours your affiant went to the Doubletree hotel at 616 West 7th Street. Your affiant spoke to one of the managers Renee Reed. Ms. Reed signed a search waiver and agreed to allow me to search Suite 1411. In 1411 your affiant observed blood on the mattress. Your affiant photographed the room and collected samples of the mattress. These samples were turned in on Property Receipt number AR-9898. The photographs were turned in on Photo file number 96097.

On August 16, 2003 at 1045 a.m. Your afflant interviewed the suspect known as "Bill" his real name is William Ernest Hauck DOB 06/14/1960. Your afflant read Mr. Hauck his Miranda Warning and collected a buccat swab.

Mr. Hauck stated that Brandon came and picked him up on July 3, 2003 in Oklahoma City Oklahoma. Brandon then drove to the Downtown Double Tree Hotel, where he spent the night. In the next room were Gordon Todd Skinner TPD # 139952, Krystle Ann Cole PID # 772695, and Brandon Green. The next day around 3 p.m. Brandon and Skinner were going to take "wafers" so they could enhance the effects of the fireworks. Krystle Cole and an unknown female were supposed to join them. William stated he went to Yukon Oklahoma to see his daughter.

Mr. Hanck stated that he returned to the Downtown Doubletree hotel with Skinner on July 5, 2003. When they arrived Brandon was still in an intoxicated state. Skinner told Hanck that he was given something else to dope up Brandon. At this time he pulled back the bed covers and Brandon's testicles were "swollen like grapefruits". Skinner than struck Brandon hard in the penis. Skinner told Mr. Hanck that he was going to get even with Brandon for sleeping with his wife.

Skinner told Mr. Hauck that he injected Brandons penis with a chemical that would cause deterioration of the tissue matter, and cause an anset of gangrene. Skinner wanted Brandon to lose his manhood. Mr. Hauck then stated the next time he saw Brandon he was with Christic Roberts.

Christy Roberts came to the room later that afternoon. Christy had borrowed Brandon's car to visit her family in Pryor. Mr. Hauck stated the Christie Roberts also observed Brandon tied up

with duct tape. Christy removed some of the duct tape from Brandon's mouth. At this time Brandon was crying to Christy and telling her that Skinner injected him with something and he needed help. Christy was trying to console Brandon. If auck heard Krystal Cole tell Christic Roberts that he was duct tape because, he started "tripping" on the drugs he had taken and they did not want him to hurt himself or get in trouble by the Police. Ms. Cole then took Christic Roberts out of the room, While Mr. Hauck went downstairs to talk to the hotel managers about getting another room. When they teturned, Brandon was docile again. Skinner later told Mr. Hauck that he injected Brandon again.

Mr. Hauck stated that at Skinner's request he took Christic downstairs and explained to her that Brandon was a snitch for the DEA and he wanted to keep her out of trouble. Christic then left. Mr. Hauck stated that he returned to the suite. Skinner then told Mr. Hauck to come here. Brandon was duet taped. Skinner then grabbed a phone cord and wrapped it wound Brandon's penis and jorked on it hard enough that he heard the "cartilage snap". Mr. Hauck noticed that the penis was bruised and almost black in color. "Skinner stated that the gangrone had probably set in and it being the penis was going to fall off."

Mr. Hauck stated that later when he returned to the room Skinner had shaved Brondon's head, eyebrows, legs and arms. Skinner told Mr. Hauke that he shaved Brandon and assaulted him anally because he wanted him to take him to Houston, where he would give him something to fry his brain and when the authorities found him they would think he was a doper "fruitcake". If Brandon did talk to the Police they would not take him seriously.

Mr. Hauck then stated that Skinner injected Brandon with an unknown substance to knock him out and he drove Brandon to Houston in Brandon's car. He stated they rolled Brandon out of the hotel on a hotel cart to the parking garage on the second floor. In Houston Mr. Hauck get a hotel room and waited for Skinner and Krystle Cole.

In Houston Mr. Hauck observed Skinner inject Brandon with butterfly needles that caused him to go into convulsions. Mr. Hauck observed Skinner do this numerous times.

Mr. Hauck then stated he drove Brandon with Krystal Cole following him in Brandon's vehicle to a field in Texas City, where he left him in a field by his vehicle. Mr. Hauck stated that Krystal picked him up and drove him back to a Houston Motel where Skinner was waiting. Mr. Hauck believes that he did this on the early morning hours of July 11, 2003. Six days after he observed Brandon in a drug induced state.

Mr. Hauck stated that Skinner and Krystal took a vehicle to another city in Texas and he caught a bus back to Tulsa. Mr. Hauck stated he began to feel guilty for what he had participated in and called DBA agents and had them meet him in Tulsa Oklahoma.

Your affiant asked Mr. Hauck why did she participate in the ordeal? Mr. Hauck stated he first met Skinner, when they were in prison together in Ponnsylvania. Mr. Hauck stated that after prison they kept in close contact and he did some illegal activity with Skinner. Mr. Hauck stated that Skinner is a drug dealer who often gets money from his mother Katherine Magrini, who runs Gardner Spring Inc at 1115 north Utica. Mr. Hauck also stated that Skinner had him convinced that if he got caught he (Hauck) would go back to prison, because he was already involved.

Your affiant then asked Mr. Hauek why he believed Krystal Cole got involved even though her and Brandon were involved and they were friends. Mr. Hauek stated she enjoyed it she thought it was something out of a movie. Krystal likes to be around drugs and money and Skinner has both. Krystal even helped clean up the room after Brandon was shaved. Krystal even told Brandon that he had shaved his head.

On August 27, 2003 Your affiant met with Brandon Green. Your affiant showed him a photo line up of the suspect known only to him as Bill. Brandon picked William Hauck out of a photo line up. Brandon indicated his choice by signing his name under the picture.

On August 28, 2003 Your affiant met with Maggie Ledbetter and she identified William Hauck as the person, who was in the hotel during the week of July 4, 2003. Ms. Ledbetter also stated that she could identify Skinner, Krystal Cole and possible the third female, who I believe is Christic Roberts. I was also given a copy of the hotel bill. Ms. Ledbetter confirmed that the suite was in disarray and the maids found hair all over the bathroom. It was so messy that

Krystal and William had to clean the room before going to another room on the 18th floor, which was checked out to William Hauck a business of Gardner Springs.

On July 11, 2003 the Texas City Police Department located Brandon Green. Brandon was transported to Mainland Center Hospital. Brandon was treated for his injuries and given a sexual exam. The sexual exam indicated heavy bruising in the anal region indicating some kind of assault. The exam also indicated that Brandon had hypodermic marks on his penis and heavy bruising in the groin area. Brandon also had marks on his wrists and ankles, which would be consistent with being bound by duct tape. Brandon head, dyebrows, legs and arms were shaved. There were cuts on his head. Brandon had cuts and bruising all over his body and was severely dehydrated. Brandon was admitted to intensive care. (for further details see medical report).

On August 16, 2003 at 1600 hours, Det Jeff Felton interviewed the victim Brandon Green. Brandon Green stated he did take the drugs voluntarily, but not to be incapacitated. Brandon remembers Skinner injecting his penis, duct taping him and assaulting him. Brandon also remembers Krystal telling him that he shaved his own head and that he was just having a bad trip. Brandon also believed that Krystal was in danger after he was in the hospital in Texas City. Brandon stated he did not know that Krystal and Skinner were married.

Brandon remembers Mr. Hauck striking him in the head and telling him to be quiet, while they were in his vehicle. Brandon stated he thought Mr. Hauck was going to kill him. Brandon still states that he does not remember everything, but things are starting to come back to him

Your affiant then tried to contact Christic Roberts through an attorney friend of hers named Mr. Butler. As of September 8, 2003 I have not heard from Mr. Butler or Christic Roberts.

Krystal Cole and Gordon Todd Skinner are out of state. Mr. Skinner was arrested in Lovelock Nevada for transporting a large amount of drugs. Krystal Cole is waiting for him there according to the Lovelock Sheriff's Department.

Brandon Green statements are correborated by William Hauck AKA "Bill" statement, hotel records, Texas City Police reports, photographs physical evidence and medical records.

William Hauck statements are corroborated by Brandon Green's statement, hotel records, photographs, medical records and phone calls. Mr. Hauck has also stayed in contact with me and is waiting to be charged for his part in this crime.

Wherefore, affiant prays this Honorable Court to issue a warrant for the within named Defendant(s), that he may be brought before and held to answer for the offense(s)
